## PROCLAMATION OF DISASTER EMERGENCY EXTENSION

WHEREAS, ON TUESDAY JUNE 1, 2010 AND CONTINUING, SEVERE STORM SYSTEMS

MOVED ACROSS PORTIONS OF IOWA; AND

WHEREAS, THESE STORM SYSTEMS SPAWNED SEVERE WEATHER TO INCLUDE

TORNADOES, FLOODING, AND FLASH FLOODING AND RELATED IMPACTS

TO PRIVATE AND PUBLIC PROPERTY INCLUDING RESIDENCES AND

BUSINESSES; AND

WHEREAS, ON JUNE 24, 2010 I ISSUED MY PROCLAMATION OF DISASTER FOR MARION

COUNTY; AND

WHEREAS, ON JUNE 29, 2010 I ISSUED MY PROCLAMATION OF DISASTER FOR POLK,

VAN BUREN, AND WAPELLO COUNTIES; AND

WHEREAS, ON JULY 15, 2010 I AMENDED MY PROCLAMATION OF DISASTER DATED

JUNE 27, 2010 TO AUTHORIZE THE IMPLEMENTATION OF THE STATE

INDIVIDUAL ASSISTANCE GRANT PROGRAM FOR MAHASKA COUNTY; AND

WHEREAS, ON JULY 22, 2010 I EXTENDED MY PROCLAMATION OF DISASTER

EMERGENCY FOR THE ABOVE COUNTIES UNTIL AUGUST 21, 2010; AND

WHEREAS, LOCAL OFFICIALS AND RESIDENTS IMPACTED BY THIS SEVERE WEATHER

CONTINUE TO NEED ASSISTANCE TO DEAL WITH THE IMPACTS OF THESE

STORMS:

NOW, THEREFORE, I, CHESTER J. CULVER, GOVERNOR OF THE STATE OF IOWA, DO HEREBY PROCLAIM A STATE OF DISASTER EMERGENCY TO BE EXTENDED FOR MAHASKA, MARION, POLK, VAN BUREN, AND WAPELLO COUNTIES IN THE STATE OF IOWA UNTIL SEPTEMBER 20, 2010. THIS PROCLAMATION OF DISASTER EMERGENCY AUTHORIZES STATE GOVERNMENTS TO RENDER GOODS AND SUFFICIENT AID TO ASSIST THESE AREAS IN THIS TIME OF NEED.



IN TESTIMONY WHEREOF, I HAVE HERE-UNTO SUBSCRIBED MY NAME AND CAUSED THE GREAT SEAL OF THE STATE OF IOWA TO BE AFFIXED. DONE AT DES MOINES THIS 18<sup>TH</sup> DAY OF AUGUST IN THE YEAR OF OUR LOLD TWO THOUSAND TEN.
